VOLUNTEER HOURS

Each family is required to complete a total of 12 volunteer hours – SIX (6) hours are **MANDATORY** at the Bingo/Casino weekend. The remaining SIX (6) discretionary hours may be completed at various events of your choice. A variety of opportunities exist throughout the school year. A fee of \$25 per un-served hour will be added to your tuition account in March. You can opt-out of performing the SIX (6) discretionary hours agreeing to pay a \$150 fee. If you opt-out now we will charge your tuition account and the payment will be spread over 10 months.

I **commit** to 12 hours of volunteer service to the school, SIX (6) at Bingo/Casino Weekend and SIX (6) at various fundraising events. Please initial here: _____

I **commit** to the mandatory SIX (6) volunteer hours at Bingo/Casino Weekend and **opt-out** of the remaining SIX (6) discretionary hours. I understand that I will be charged \$150 over the ten month school payment plan. Please initial here: _____

FUNDRAISING FEE

Each family will be assessed a \$225 fundraising fee. This fee may be lowered or eliminated by participating in any of the school sponsored fund raisers. You will be credited an amount equal to the profit we make on each fundraiser. If you do not meet your fundraising goal, you will be charged for the amount to fulfill your obligation. You can opt-out of participating in the various fundraisers and pay the \$225 fundraising fee with your 10 monthly tuition payments. If you exceed the required \$225 you will be credited the full amount of fundraising you achieve as a credit to your tuition account.
